Sir,

I am directed to refer to this Office' letter No. F-24026/09/2022-CDN/147 dated 31.05.2022 on the above mentioned subject and to clarify that the **NOC from Land and Development Office will not be required in the following cases**:

- i. For registration of 'Will', 'Gift deed', 'Relinquishment deed', 'Rent Agreement', 'General Power of Attorney' for both lease hold & free hold properties of L&DO;
- ii. For registration of Lease deed & Supplementary Lease deed;
- iii. For registration of sale/purchase of properties which have been converted from leasehold to freehold on or before 31.03.2000.
- iv. For registration of 'Conveyance Deed' issued from L&DO & 'Partition Agreement' for Freehold properties of L&DO;
- v. For registration of Shops which were under the jurisdiction of L&DO but stand transferred to local bodies, viz, NDMC, MCD in the year 2006 as all records were transferred to respective local bodies for the same. However, in such cases local bodies (NDMC/MCD) may issue NOC, if any.

2. Further, it is informed that **as of now there is no processing fee for the NOC** and the NOC issued by the office of L&DO will be uploaded on the website of this office. Sub Registrar Offices are requested that authentication/verification of NOC issued from this office may also be done from the NOC uploaded on the website of L&DO at https://ldo.gov.in under NOC tab on home page.
